3. Terms and Conditions:-

- 1) The proposed school complies with all the standards, terms and conditions prescribed by the Right of Children to Free and Compulsory Education Act, 2009 and the Maharashtra Right of children to Free and Compulsory Education Rules, 2011 and the directions issued by the Government under this Act or the standards specified by the Government, from time to time, or the standards specified by the Government or will fulfill the terms and conditions.
- 2) A registered institution or trust or company shall comply with all norms, terms and conditions prescribed by the Maharashtra Self financed Schools (Establishment and Regulation) Act, 2012 and according to the Act, it is mandatory to comply with the standards specified by the Government from time to time as per the directives issued by the Government.



- 3) C.B.S.E. or C.I.S.C.E. or C.A.I.E. or I.B. etc. board, as per the instructions issued by the Government from time to time, to obtain a No Objection Certificate from the Government.
- 4) The school management shall inform the concerned District Education Officer before the approval of the academic year sanctioned by the Government.
- 5) A permission granted for the establishment of a new school or for upgrading a school, subject to the provisions of this Act, shall be for the academic year for which it is granted.
- 6) If the school management, within 18 months, fails to start the school, the approval letter issued shall stand cancelled.
- 7) The school management, approved medium of education, location of the school shall not be changed in future without the permission of the Government.
- 8) If the school management establishes the school at a place other than the place approved by the government if so, the permission of that school will be revoked.
- 9) It has been provided that the recruitment of teachers and non-teaching staff in self-financing schools should be done in accordance with the prevailing rules and regulations of the Government.
- 10) While filling district wise information, the school to which permission has been given shall fill the information as "Self-

financing School" as a separate category and U.D.I.S.E. will get the number. In this regard, the State Project Director, Maharashtra Primary Education Council, Mumbai has been declared as the Nodal Officer has been done.

- 11) The school management shall install board as "Selffinanced Recognition school " on entrance of school.
- The State Government may, at any time, cancel the 12) certificate of approval on the ground of breach of any of the provisions of this Act or the rules made thereunder or failure to comply with any directions issued under the Act or the standards or standards or terms and conditions specified by the Government from time to time.
